## ELECTION OF OFFICE BEARERS FOR THE TERM 2021-24

For the information of all the members of State Bank of Patiala Retired Officers Association(Regd.), Patiala, we inform that in terms of Bye Laws of Association, the members are to elect office bearers of the Association for the term 2021-24. The Executive Committee of Association in their meeting held on $9^{\text {th }}$ October 2021, have appointed the undersigned as Returning Officer for the purpose of conducting election at Patiala. Shri B.S.Jaggi (Membership No.859) will work as Assistant Returning Officer in the election process.
The election shall be held as per provision of Constitution/Bye Laws as amended up to date. We inform the members to go through the provision as given under clause 9 of the Bye Laws under the "Head" Elections(eligibility, duties and responsibilities of Returning Officer)read with clause 5 (Membership).
We give below the important points for the information of members in this behalf.

1. Eligibility criteria of the candidate seeking election: Membership is open to all the retired officers of eState Bank of Patiala to be enrolled as member under clause 3(a) of the Constitution. However, a member shall not be eligible to nominate, support the nomination or agree to such a nomination or cause himself/herself to be nominated unless he/she has paid membership/annual fund/Levy etc. up to 30.09 .2021 . A list of members as on $30^{\text {th }}$ September 2021 whose position with regard to payment of subscription/annual fund/levy etc. as on $31^{\text {st }}$ March 2021 is regular or those who are specifically exempted from payment of subscription, having reached the age of 80 years will be available with me/Association Website. The position of subscription/annual fund/levy in arears has already been advised to the members individually by the Association. The member of our Association who is member of any other similar retiree Association in eSBOP/SBI is not eligible to contest for the post of any office bearer and also can not support/endorse any nomination.

3. Criteria for filing Nomination Paper: This is to be done by an eligible member(as per paragraph 1 above) duly signed by self as also by two other eligible members within the given time schedule. For convenience, specimen of proforma devised for the purpose is enclosed. An eligible member can contest for one post only.
4. Time Schedule :
a) List of members and overdues there against will be uploaded on Association Website by $10^{\text {th }}$ November 2021.
b) Submission of Nominations will start from by $22^{\text {nd }}$ November 2021 (10 AM)
c) Filing of nominations to reach the returning officer by $29^{\text {th }}$ November 2021 (5PM).
d) The final list of valid nominations after scrutiny will be announced thereafter.
5. The term of the office bearers ( 10 in number) so elected shall be for Three Years (at present) from the date of taking over and the Executive Committee members will be nominated afresh thereafter in terms of clause 7 of the Constitution/Bye Laws of Association.

While we shall be discharging our duties with utmost sincerity and honesty, co-operation of all the members is utmost necessary as my duties/responsibilities include making efforts to hold the elections unanimously and avoiding contests, as per provision 9(iv e, fand g) of the Constitution. In such cases, a panel of names of the eligible members to be elected for various posts will be put up to the House (General Body Meeting) for approval and if approved, other nominations received for posts, will get cancelled automatically. After the elections are held we shall announce the results and the Association will issue the circular for the information of members. Our address and contact number are given below:
