Organisational Issues

A meeting of the Executive Committee of State Bank of Patiala Retired Officers Association (Regd.) was held on 8th August 2022 to discuss the following items:

- i) To confirm the minutes of the previous meeting
- ii) To consider strategy to improve collection of subscription for 2021-22 & 2022-23
- iii) To discuss latest bipartite talks on pension
- iv) To discuss progress of enrollment of fresh membership
- v) To discuss organizational issues including reconstitution of EC and to fill up the vacancy(ies)
- vi) Any other issue with the permission of Chair

The meeting was held under Presidentship of Shri Rakesh Jasra, Senior Vice President in absence of Shri Harish Walia who could not attend meeting due to illness. While welcoming the members, Shri K.S.Sandhu General Secretary appreciated and thanked the members for making the General Body meeting a grand success. Two minutes silence was observed remembering the persons who left us during the intervening period.

The House unanimously wished early recovery to Shri Harish Walia, President.

Thereafter, minutes of the last meeting were read out which were confirmed by the Executive Committee and meeting started discussing issues as per agenda circulated.

a)Expenditure incurred during the intervening period and in holding the conference was confirmed.

- b) Review of subscription was done. Lists of overdue were handed over to all unit secretaries. It was decided to extend benefit of one time payment of Rs.2100/- (Rs.1400/- for previous years + Rs.700/- for current year 2022-23) from all such persons who could not pay their subscription for the last years.
- c) Balance sheet for the current year is under preparation and income tax return will be filed shortly.
- d) It was decided to create new units at Amritsar & Sangrur.

- j) General Secretary informed that the members residing at Patiala, Rajpura, Nabha, Ambala etc. may avail medical facilites from LHO Chandigarh where the doctors have consented to check up and to provided free medicines as per bank scheme.
- k) The meeting ended with Vote of Thanks by Shri R.C.Jasra who requested the members not to criticise members on social media. Instead they can discuss their issues to clear any misunderstanding.
